



## 39 Slips Condo Marina w/ Declarant Rights.

\*Separate condo slips. Owner gets full declarant rights.

\*HOA is inactive. New owner can activate and start charging HOA Dues to the 16 Owners in the building that own slips.

\*Any repairs that are made can be shared with the Homeowners. (You can exempt yourself from any dues.)

\*Marina Boat Slips are 12 ft. wide, there are a few 14 ft. wide slips at the front of the piers (1 each side)

\*Electric service is 20 amp. Water meters are in place.

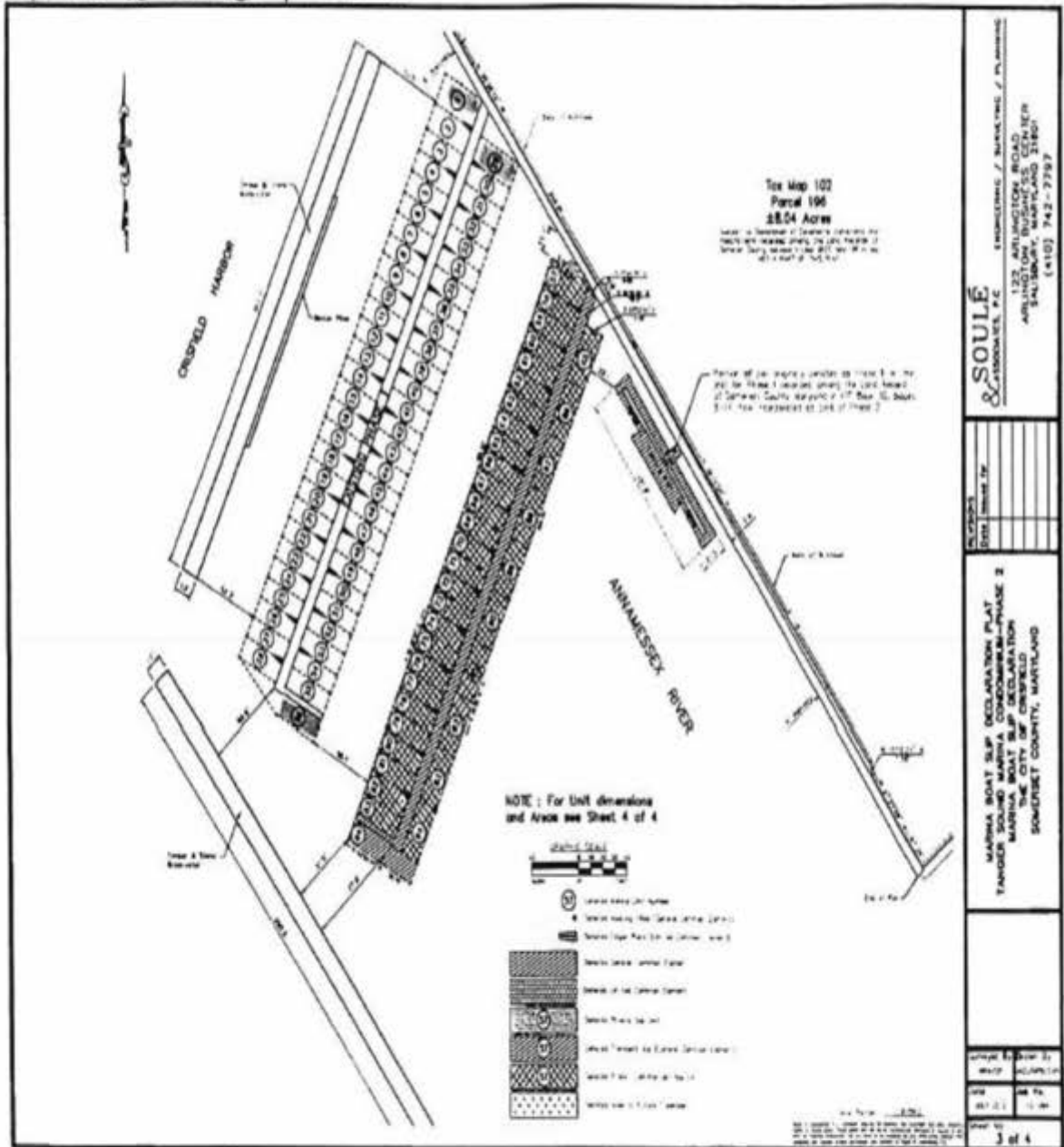

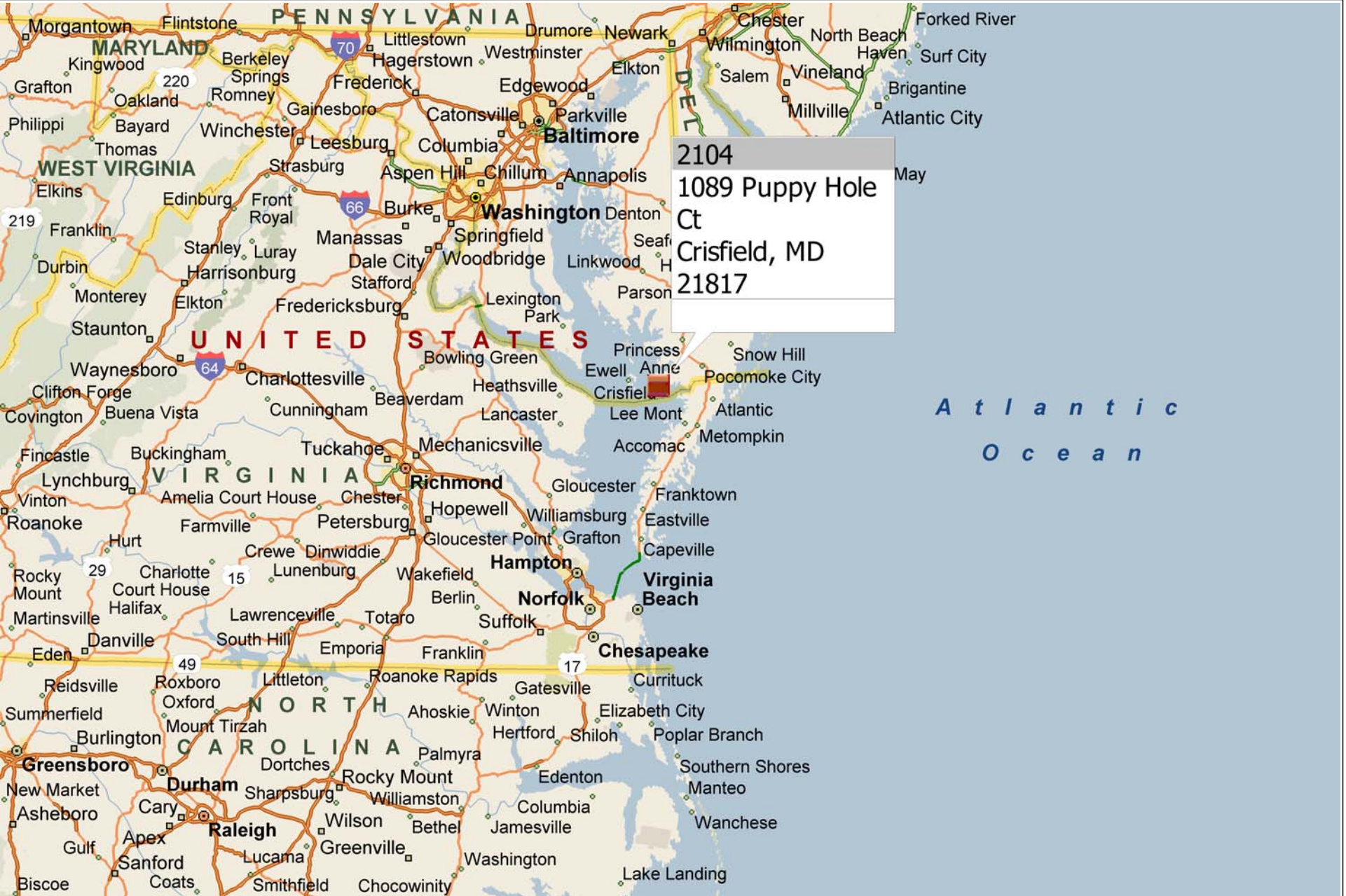

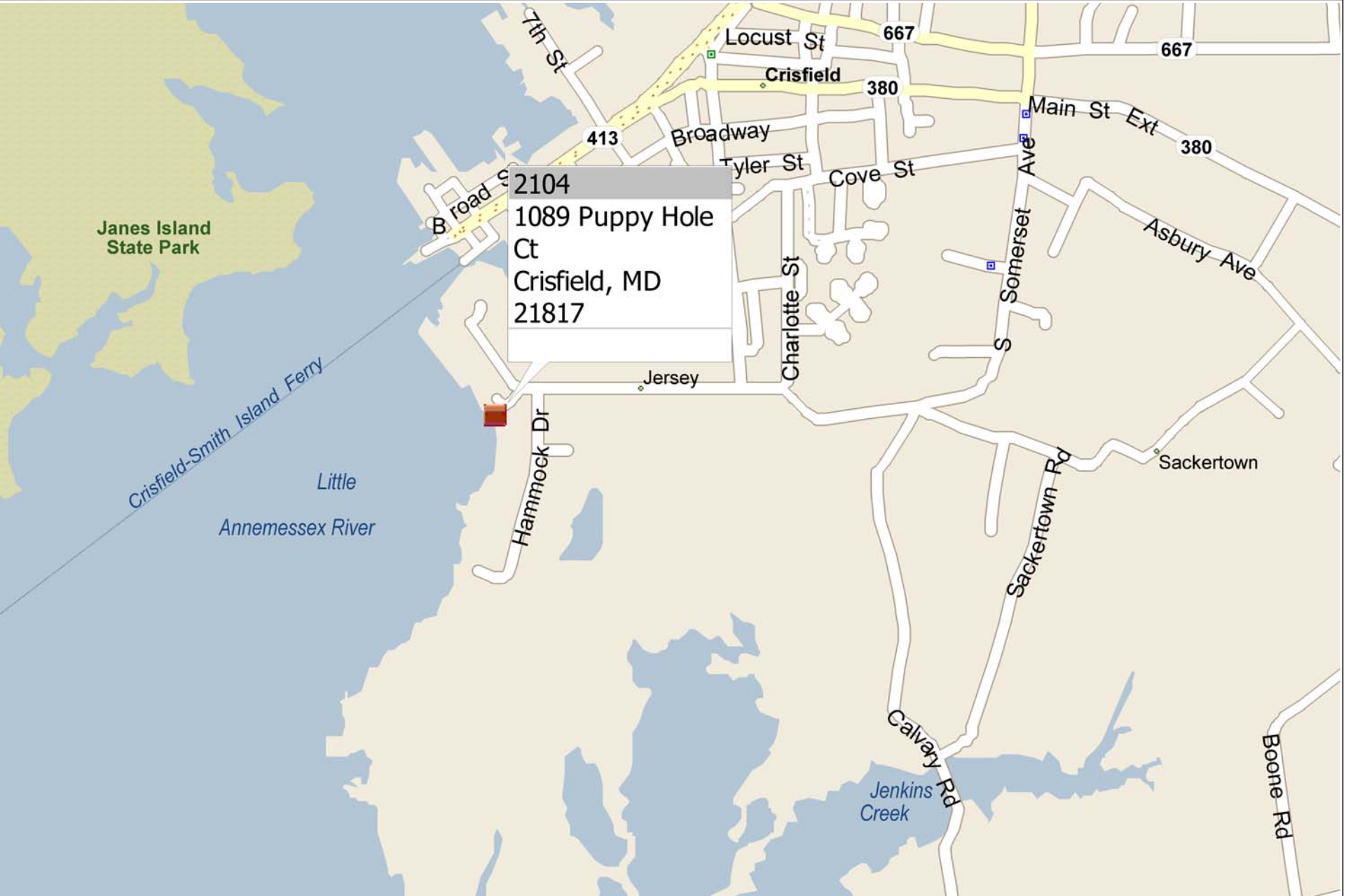
